We will be amending the Ordinance and send it back to the Townships for their approval. There is a difference between spot zoning and rezoning, and conditional rezoning the developer comes with a specific purpose in mind.

- A. Public participation related to the subject matter of this public hearing. The Chair will declare such a public hearing open. They would like to have a second event. Last year they had 3,465 attendees on one day. Happy that event went smoothly.

- C. Special Use (amendment) [Hoxeyville Productions, LLC] Findings and Conclusions, and Decision (Article 86, Section 8609.A)

Nathan, the Attorney mentioned to add a second event, and change to the Site Plan. To move stage and add stage. They would like to have security check in changed from SE corner to SW to have and add a drive in check in and have three to five check in spots. Does not affect sound levels. Second change to have a second event, shorter in May along with event in August. Run times and operational will be same as August. Campers only event, no day event tickets. One stage will be running at a time, to reduce sound levels. Expect to have around 2000 attendees.

Audience: Michelle Horina is a resident and would not like 3000 people in their backyard. Dennis Horina said noise is not tolerable and would not like another event added. A Board member of the Cadillac Tourism Authority said that the County and industries in the area thrive on festivals. Would like to see another event added for the community. Carol Sternick and talk to commissioners about having a festival in their backyard. Can not sell the property with many events throughout the year and to think about the residents. Carl Sternick read the July 2017 minutes stating that there will be one event per year. Less than a year after approval and now asking for another event and he is a resident and against it. Joe Host, Ski Shop, and have worked with Festival and use as a fundraiser for high school ski programs. Many new people come into the area to move here. Kevin Tupin attends festival and knows many of the residents and some are benefiting and enjoying the festival. As a citizen and attendee and is safe venue and many family members that make money off festival and enjoy the venue. Feels it is beneficial to the area and is for

having another event. Sheila Pratt, Harrietta, said trespassing should not be allowed. Pete Finch from Hoxeyville and Coyote Grill is supporting the festival and adding the new event. Ask Commissioners to consider to add the new event. Donna Taylor spoke as a public attendee, that the community has to grow to thrive. This event is very clean and family oriented and the community supports it. Carol spoke that this is a residential area zone so put the event in a commercial area. Rick Emhart attends the festival and knows the promoters and many people work there and enjoy the festival. Nathan talked that it is forest use and used for camping and family event. Believe it is benefit to the community. Carl made a suggestion to move the venue with other properties that owners have up for sale on Hwy 55.

Staff: Bob and Ben will walk through staff report. Bob wants to let them know that both properties owned are zoned rural residential. Ben spoke to represent the ordinance itself. Event is going to add a longer check in inside the grounds and get cars off road, and preserve east side for performers. Need to approve a three day event in May. Bev asked about the decimals of sound and Bob referred to Nathan and the 110 decimals levels is max when they were under another zoning laws. This level is safe and is leveled by sound engineers and inside the property. Has had 75 decimals on the western boundary it limits at 110 decimals at the stage. Organizers hire security and in camping areas music is played but no electric instruments and drums are allowed. Ben went through the standards, requested by Bev. Read and went through. Questions on fencing. Bob received several letters and put online and promoters should address the trespassing issues. Dave has closed the public hearing.

Discussion on Public Hearing #1, Bev Moved and Marty second to recommend the adoption of the proposed conditional rezoning ordinance. Discussion, Motion passed. (Dave Williams is opposed)

Discussion on Public Hearing #2, Nathan said that the event organizers would agree to limitations discussed as to limits to 3500 attendees per day, two events per year, that a fence be put up at north end by Horina Trail north 200' and south 200' and all the way to 37 on east in the northeast section, using metal stakes with four wire across with no trespassing signs. Moved by Marty second by Dave to accept the recommendation of the administration for the Site Plan with the issues of fencing on the site plan with two events per year, 3500 attendees max per day. Motion passed.

Discussion on Special Use; All standards are complied. Motion by Marty second by Richard to accept the addition of an event in May with special use permit. Also to have the second event to not hold the event over the Memorial Day Weekend. Motion passed.

Discussed ending the meeting at the two hour limit. All agreed to continue through the treasurer's report and pay bills.
