# **Staff Report**

#### **Planning and Zoning:**

The WJPC office is now about 6-1/2 weeks ahead of the permitting process when compared to the same time frame as last year. We have benefitted by NOT having any Zoning Board of Appeals activity to date. We actively work with the applicant's to seek compliance rather than approach the applicant's desires through the variance process.

## Master Plan: \*[ACTION ITEM]\*

The Planner of Record has submitted a proposal to complete significant public input / visioning sessions (see attached). The Planner of Record and Zoning Administrator (through numerous conversations) were able to substantially reduce the cost of this process by more accurately defining the actual scope of the work to be performed. *The Planning and Zoning Administrator recommends approval of the proposal* dated July 12, 2018 in the amount of: \$5,500.00 to facilitate resident / stakeholder input sessions. The Planner of Record and ZA will work together to publish and facilitate the public input sessions. The Planning Commission will be contacted via email regarding dates / times / locations. All Planning Commissioners are encouraged to attend ALL sessions but it is certainly not required. There are four (4) tentative locations: [Wexford County Road Commission, Greenwood Township Hall, Cherry Grove Township Hall, and Harrietta Village offices]

It is the intent of the Planner of Record and staff to begin publicizing and conducting these sessions as soon as practical. We would like to complete this task not later than the end of September.

Asst. Zoning Administrator Ben Townsend will be attending 'Hot Topics' in Planning and Zoning / a request for reimbursement has been submitted with this months bills and is supported by the training budget.
