3. Planning and Zoning Report – **Robert Hall** - (see submitted Staff Report) – Mr. Hall pointed out the fundamental change to the Agenda document going forward. Update on Mud Bog court case. Ruled in our favor, puts the client on notice, and needs a permit going forward – being contested in Circuit Court by defendant. There are currently two (2) upcoming ZBA cases planned for Wednesday, July 24, 2019. Training available August 27 – topics include: Composting, drones, tree ordinances, tiny houses. On upcoming Agenda – Manton Pines (Liberty township) seeking Special Use Permit for future outdoor events. Campground on 55 – Mr. Hall & Mr. Townsend are working on it.

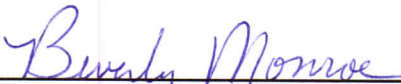
