Wexford Joint Planning Commission

Now that the grant has been awarded to the WJPC, we should act to formulate a plan based on community '*housing*' priorities. As a reminder, the funds are only available through calendar year 2024.

Staff is currently preparing and 'announcement' to send out to the participating municipalities advising that we have received the grant *and* informing them that their assistance is needed to be successful in our future endeavors.

Staff will also be working on the budget to accommodate future goals of the WJPC regarding this opportunity and others.

Participating Municipality Concern(s):

Since Cherry Grove Township conducted a public hearing on Wednesday, October 18th, 2023 as required under Section 11 of the Ordinance and Agreement. There has been no recitations / findings presented to staff for consideration of a budget to withdraw.

Staff encourages 'continued' discussion on the feasibility and opportunities that ad hoc committees could present for the WJPC in accomplishing greater efficiency on behalf of the participating municipalities. Consideration should be given to formulating a work-plan for the MDARD Rural Readiness Grant
